It has been a while welcome. to your first episode of curious realm.

Hey, Chris, thanks for having me back on. It's good to be on the new show. Oh, looks man.

C Chris Jordan 05:09

Oh, thank you, thank you. It's always a pleasure having you on we always have such great conversations. And like I said, pre show, it's been great to see you kind of stretch your legs with more research than what you have done in past years here recently. So before we get really involved, let's go ahead and familiarize any new listeners with who you are, what you do, and how you came to be involved with the now famed blanc blind frog ranch.

J james keenan 05:43

Yeah, sure. So after putting in 20 plus years of law enforcement and private investigation, you know, I just got tired of it. I had my degrees were in anthropology and archaeology, I'd done a lot of work and, you know, Mesoamerica, excavation wise to get those. And I figured, hey, it was the time to, you know, do what I finally wanted to do. So not too keen on writing nonfiction, because I don't like having to put all the sources and everything in there. And then, you know, with some nondisclosure agreements, you can't really talk about it. But heck, if you happen to write fiction, you know, a lot of the truth can be put into what you're writing, along with the storyline. So, you know, seven books later, and the eighth one is about to come out in mid March, I was did a deep dive into the connectivity between Mesoamerica and the Desert Southwest and Scotland, Armenia, Sardinia, and so traveled around the world started seeing all this unexplainable phenomena at multiple locations sites, especially in Mexico and the Southwest, started seeing that there was a lot of oral tradition and real written down history, whether it's on rock art or artifacts in regards to the giants of old. And I wanted to familiarize people with it more so not just with the same regurgitated information that's just continuously told, but to try to let people know what's right, what's wrong. Meaning, you know, what really is the truth or what articles were incorrect or, you know, when you're talking about the ancient alien artifacts out of a weightless day, at least go that one out of every 10 to 15,000 is the real deal. Well, and let's start getting into that area real quick that you and Todd base and because that is that is there are a few areas in the world and even in our country, James that. I mean, we have one right down the road from us here, at least, it was called wonder world when I was a kid, I don't know if it's still around or not. But it was one of those places with like, wacky shacks, where where stuff went, like water ran up hill, you know, all kinds of wild things like that. Just just odd vertices and vortexes and anomalies. And it seems like the U and TA basin is a magnet for these anomalies.

Yeah, literally, it seems like there is a huge magnet underground. So that was a good play on the words. It's just a place of a lot of phenomena. And it makes you wonder if whatever is occurring, I personally think it's underground. If it attracts the phenomena, or if it creates the phenomena could go either way. But there's just so much occurring. It's not one thing, it's many. And you're able to collect all this information and data for so many different types of things occurring than if you were to go elsewhere and only be able to, you know, investigate or research on one topic here. It's it's many At one time, yeah.

And let's, let's start getting into some of these. I'm actually bringing up a USGS survey of the area. But there are there have been, I mean, of course blind frog ranches named such because of the frogs that are there. But let's start getting into a little bit of the supposedly cursed history of the property. There was the whole caveat for a long time, which was talked about at length in season one of mystery of blind frog ranch the whole you know, don't dig was was the instruction.

Yeah, well, the don't the dotting was on Skinwalker Ranch at the at the at the blind frog ranch. They started digging, they've been digging for years looking for this treasure. This suppose a treasure that could be the Rhodes mine or it's also known as the Mormon mine or the Brigham Young mine it may also be, you know, the hidden naztech treasure that they hid from Vernon Cortez when he was pushed out of to notice the lawn and 1520 before he returned to conquer them. It also seems to be a location or at least around there somewhere. This bot known as care Shin OB or Tom one con in ancient Mesoamerican culture, where its origin for many species, including the people, Giants and humans, whether that's them having survived their from multiple major catastrophic events, the last one being the great delusion, you know, and also burial for kings and gods. Yes, it's been 1000s upon 1000s of years, you have the San Juan River culture, which were the Ancestral Pueblo or maybe even pre Ancestral Pueblo, which go back into the Archaic period. You have the desert, archaic people, which comprise of, you know, barrier Canyon style culture, which has this rock art that have anthropomorphic and zoomorphic figures that look like anything but normal day living. It's missing everything that shouldn't be there like corn and musical instruments and day to day life. But it has these things that look like I mean, it looks like artificial intelligence moving around, it looks like other type of species maybe. And people reptilian alien. It's just truly bizarre. But the most important in that scene all over, especially throughout Utah are the Giants and like you said, it goes into Nevada with the Paiute in Lovelock cave with the sea take car, which were specific tribe, there were supposedly the redheaded cannibal giants. But you had other groups too, you had probably the star not K, which were the mining giants. And you know that if you've listened to star Nakia, it sounds a lot like the Anunnaki. You have more ancient groups that can annex in giants that go all the way down into Mexico. So you're talking just tons of ancient races that could have come from elsewhere or just been here for a long time before we showed up on the planet.

And with that in mind, specifically, let let's start exploring some of the possibilities there on modern day blind frog Ranch, like you said, supposedly, and I've been I've been watching the episodes for this season. And I love the stuff that you guys are doing afterward. It's It's really great to hear deep diving into things and examining the episodes after it comes out because of course, there's tons of stuff that you guys find tons of other research that occurs. That does not make the show.

Right, and what you're talking about is, so it's on Friday nights, and then Saturday mornings at 11am. Mountain Time. It's the podcast for the mystery of blind frog ranch where we have, you know, Charlie boy or Dwayne Hollinger chat, all injured. Jamie, we had Dr. Segalla, Jim Segalla. On this weekend, I happen to not be there because I was given a presentation with Dwayne Hollinger here in Phoenix, Arizona. But I mean, gosh, you know, Dr. Sagala, was on Season One of the secret Skinwalker Ranch. He knows his stuff. And I miss not having been able to talk to him.

Well, and you know, what was the what was the presentation? Like for you guys here recently, because I know, y'all have been going out and making some appearances. I know, you've got an upcoming conference in Sedona that both of you are going to be at So how has that been

going? How's the show been received in the research been received by the audiences out there?

J james keenan 16:32

Yeah, so, you know, the show has a huge following. It seems like a lot of people love it. A lot of people hate it, it seems that people that seem to hate it, watch it more than the people that love it and talk about it more.

C Chris Jordan 16:49

The only way you can rag on it properly is if you watch it all the way through, right.

J james keenan 16:54

Right. You know, you gotta remember to you film for these guys on the show they film for weeks and weeks and weeks. Yeah. And, you know, one episode is only 40 minutes, with 20 minutes of commercial and that you can't show everything. So it's a pick and choose that's done on the editing table. So that was kind of why they we put together the podcasts so that we could, you know, discuss more of what occurred the night before answer a lot of questions that are out there. But yeah, I mean, you know, I, I deal strictly with the scientific part of it, or the oral tradition, the Native American aspects of it. I do you dive into looking for the treasure, but I keep all that separate from what's occurring on the Discovery Channel show that that's something that cargas seven is doing. And, you know, I think it helps due to the fact that I'm able to keep a lot of those data points and scientific information, separate to where my hypothesis can't be manipulated. Yeah. And I am hoping that at some point here, in the near future, there will be a major discovery made, whether that be you know, during the course of the show, or on an off, season off point of filming. And that's another thing you got to remember too. So a lot of stuff occurs when it's not filming. So the only way to be able to provide that would be through reenactment or, you know, telling the story of something that happened in the last, you know, nine months. Yeah, so it's just a matter of, you know, explaining it more in the amount of time it's possible to do that.

C Chris Jordan 19:04

Well, and the research that you've been doing has gotten pretty in depth. I know you were whenever you first came on the show a couple years ago, you were doing some light surveys, things like that. But let's start getting into some of the wild science that you have been using out on location to, I guess, collect the phenomenology of what's going on at this location.

J james keenan 19:34

Sure, so I introduced 3d ground imaging. I now have a 3d ground imager with the GPR the ground penetrating radar. So I'm capable of looking into the ground in a non invasive manner. It almost feels like it's cheating because I know what's in the ground before digging, and I have

incorporated to it High, well, intense depth metal detection units, meaning they can go anywhere between 10 and 18 feet underground, which is unheard of. We've also been using K band radar guns which operate at 34.7 gigahertz to interact with UAP. Not on the ranch, but very near to it, which has just been something I had never seen done. You know, a lot of people, you could show them all the video on the world and cry that it was photoshopped or something. So I came up with something that worked, it comes in contact with the surface of these UIP showing that they're not just light, but that they do have some type of hardens you no outer surface, and collect that video and photos of it. Wow, I've shown some of the photos, but I'm keeping the video for a specific project that will hopefully appear for the public probably within the next 18 months.

Wow, that is incredible man to know that you've come up with a system to actively be able to see these UAPs. Now, you were saying that there's light, so obviously you can see them without this device. But this just shows the fact that they are just a source of light, or you know, a glow stick on a on a drone or something like that.

J james keenan 21:42

Correct. And, you know, I'm within 200 feet of it. So I can see with my eyes that it's not any type of drone that I've ever seen. And what's interesting is it seems to be evading the microwaves that are sent out from the cage and gun. It's the same thing that catches people speeding but it used by law enforcement. And I had initially tried to laser radar gun and it didn't interact with it, it didn't seem to even notice. But the moment I use that pop radar with it, it just started doing some evasive maneuvers. Moving from 11 to 44 miles per hour. And after 92 seconds, it just disappeared. And I'm not talking about flying off. It just was gone.

C Chris Jordan 22:33

Wow. Now notice this society, I don't want to get into too much stuff. I don't want to I don't want you to give away any proprietary information, or anything like that. But are you able to visit? Like there's one thing to just saying like with data? Yes, there's something there? Are you able to see what's there with your system?

J james keenan 22:56

Well, I'm videotaping that. And has I'm using the guns so I'm capturing myself in front of the videos and the video the cameras also capturing the UAP. Wow, while I'm interacting with it.

C Chris Jordan 23:12

Wow. That is That is pretty cool, man. That is That is incredible stuff.

J james keenan 23:20

And it's it's it's amazing.

C Chris Jordan 23:23

Now, when you're when you're saying interacting, is this like flashing? What are you calling interacting with a UAP? Because I mean, they're of course, the CE five studies going on with Steven Greer, all that kind of stuff with people mass interacting with UAP is there are people who have said, you know, use these lasers and you can interact with UFOs and UAP is but what are what are you? What kind of interactions are you getting from these objects right now?

J james keenan 24:03

Sure. So, when I initially hit it with the pop radar, it starts moving, trying to get away from it, I'll turn it off. I'll remove my finger from the trigger of the radar gun and it'll settle back into a spot and then I'll turn it back on on it and it does the same thing it and if I keep it on there, it keeps moving and trying to get away from it. And it's returning the microwave signals of 11 miles per hour to 44 miles per hour of movement, the speed of this object and you're talking about it moving up and down left to right, but not a long distance not far away. It wouldn't leave. You know, like I said it was only a couple 100 feet in front of me and it's not Like, darted away or shot up into the sky. And then after 92 seconds, it just disappeared.

Wow. Wow. And now, how do you think this relates possibly to the finding of cameras on property? This last year? Do you think that maybe that is some sort of observation drone or anything like that?

J james keenan 25:31

Yeah, that was interesting. I don't know what to make of that. I do know that. You know, I watched that episode. And it was, it was an expensive piece of equipment. Yeah, you know, it wasn't anything cheap. It it, it was able to be connected to, you know, from a distance, it had solar panels for recharging. It was a PTZ, which is a point to zoom system that could focus in and out to great lengths

and able to track individuals,

and able to track individuals, as the tech said on the show. Exactly. Yeah, I don't know. I mean, like I said, you know, was what I was interacting with maybe just a high tech drone that was

like I said, you know, was what I was interacting with maybe just a high tech drone that we don't know about yet. I mean, that's that's an absolute possibility. I mean, it's an unidentified aerial phenomena, I don't know, now be something that we end up seeing in the next two years.

Absolutely. Now, on the property itself, there has been found quite a deposit of iridium which, which in and of itself carries certain properties. And especially when in huge quantities, can do all kinds of wild stuff. Do you think that any of this is related to the radio more than anybody watching the property is perhaps trying to come in and like, strip mine or kind of Slant mine the Iridium off property or something like that?

J james keenan 27:18

I mean, it's always possible, you know, they on the show, they stated that the assay came back at three and a half million dollars. Unfortunately, the state of Utah is very strict about mining, and it would require mega amount of permits to do that. Yeah. Even though it's private property, that doesn't matter. Because you know, they're live streams running through the property, the wildlife, there's protected. But, but what's interesting is people have to realize that, in a regular sample of the Earth's soil, there's only 1000 part per million or radium. That's point 001. On when an asteroid or meteor strikes the planet, and you find sharp quartz, you'll also find about 4.5 to six parts per million, which is huge. Well, my two samples that I took, came back at 10 and 60 parts per million. Wow. Which is massive. And then obviously, what you saw Eric show on the show on Discovery, I mean, that his assay came back even more at three and a half million dollars, which is I am it's huge.

Yeah, it is.

J james keenan 28:41

I mean, it's possible.

C Chris Jordan 28:43

Yeah. And, and even the the metal that Dwayne himself wears around his neck, the properties of it and the way that they are able to manipulate it is just really, really strange. Very, very interesting stuff. Yeah, yeah, literally, like modern alchemy. And go ahead.

J james keenan 29:08

No, that's the exact point that Dwayne is trying to explain to people is that it is it's alchemy, the fact that he's capable of doing this. I've never seen him personally create the metal. I've

the fact that he's capable of doing this. I've never seen him personally create the metal. I've seen all the equipment up there. In the energy zone. There's three energy zones that I know of this is probably the largest of them. And you know, obviously, it's not all the time that it's capable of being created. But just the fact that he can do it. Five out of 10 times, or whatever it is, is just amazing. Yeah. And I mean, he wears that thing around his neck all the time, and you just can't help but stare at it. It's just so cool.

Yeah, yeah, it is. It is it in and of itself an anomaly. And it's just really interesting to see some of the strange things that go on on property over there. What's some of the wildest stuff that you've seen? Since you've been researching here? Because, of course, you've been researching on the property since well, before the show started filming anything like that?

Correct? Yeah, there's, you know, a lot of people have said they've tracked Bigfoot on there. And, you know, I've never had any occurrence of odd doubt that at Blind Frog Ranch, but I have had some major equipment failures, including, I had a pretty expensive magnetometer fry itself, I don't quite know how it occurred, allow, but it just, it goes to show that in these locations, these phenomena locations around the world, that there's this, there's these categories of repeating paranormal phenomena that occur, and it seems like one of the biggest ones is, is the disruption of these electronics and technology. And that's ongoing, I've had that occur, you know, elsewhere on the UN top base, and multiple locations that are tied in to this transient phenomena that's taking place, because there is there's this transient energy that occurs. And, you know, being it's starting to be tracked, and we're learning more about it. And it's just interesting, but I think that would be the biggest thing, we've had some interesting experiences that I would almost have to relate or say it has to have something to do with the Native American background, and it being land, you know, their land, and it's hard for me a lot of the times to discuss, you know, personal paranormal experiences are unexplainable, I prefer to say, when I'm trying to collect the scientific part of it, but you know, it's happened and I can't deny those occurrences of you know, feeling like something, put your, its hand on your shoulder, and you turn around in a certain location, and there's nothing there, where you constantly feel like you're being watched around a certain tree, on the property that has a lot of Native American history to it. And, and it's not just, you know, me or me alone, it occurs when there's multiple people with you, and they the same occurrence, they end up going through as well. So no, a lot of people, you know, they'll call BS unless they either experience it, or you have some type of physical evidence. And unfortunately, you can't be ready for something like that, to capture 100% of the time, it's just, it's not possible. So, you know, over the years, I've caught bits and pieces of this, I've been able to provide evidence for that, or a lot of my hypotheses have been wrong. And you know what, that's great, because that's what the science is for, if I include myself wrong, I'll move on to the next hypothesis. And I'm more than happy to say when I've been wrong, because at some point, I'm gonna get to what I believe is really going on and be able to prove and show that it's happening.

That's right. And I think what a lot of people forget, James, that we talk about on this show repeatedly is that according to scientific theory, you're allowed to hypothesize, hypothesize, and

regularly, is that according to scientific theory, you're allowed to hypothesize any old thing. It's through theory and experimentation that we prove it. And to know that, like you said, numerous of your hypotheses have come back wrong through that experimentation in theory. And it's okay, that doesn't mean that you stop hypothesizing, that doesn't mean that you stop considering something else or other alternatives.

J james keenan 34:32

Exactly. And you know, what, there have been some things where we've had a repeatable outcome, you know, I can do it over and over again, and the outcome is always the same, which is exactly what I'm looking for. And at some point, I think all these little bits and pieces, you know, call it bits and pieces of the puzzle at some point will be put together and we'll be able to see the real the big picture of what's happening. I firmly am a believer 100% that whatever is occurring it's because it's below ground. And I have never broken away from that, that. And that's why we've been underground and a lot of these caverns and tunnels systems that not everybody knows about. But I mean, it's you and Tom mountains and parts of the basin are just littered with cavern systems or underground voids,

almost a honeycomb artifacts.

J james keenan 35:24

Yeah. And you know, it's interesting because I mean, you're talking about the past a very good possibility of an asteroid or Meteor having to hit this place when it was late you into, which would have created massive fissures through all the limestone that's there. And then there is a lot of faults in the area. It's a very active area, you know, and then the you have a ton of hydrocarbons and ancient fossils. This was where the dinosaurs roam. So you have a lot of interesting, distant past history at this location. Yeah,

yeah. And a lot of really, really interesting and odd geology in one spot. Like you were saying the fact that there's obviously been an impact or something like that at some point there. Which explains the iridium. Even if there's some sort of huge magnetic deposit from from a meteor, it would explain a lot of things now, with your measurements. I know on Skinwalker Ranch, they've done all kinds of stuff, from shooting rockets in the air, to getting measurements and helicopters, all kinds of things. To find out that there's it's almost like, energy is being focused, like it's a dish in the area. Are you guys finding that same thing to be the case over on blind frog ranch? What? What kind of data have you found in that concern?

J james keenan 37:06

It's absolutely, excuse me, it's the same thing. Like if you remember, when I was on secret of Skinwalker Ranch. I was using the magnetometers on at the triangle. And. you know. I know

there's water running underneath the property. And I was able to show that when they drilled, that's exactly what they found. And this is everywhere. It's not just underneath the Mason at Skinwalker Ranch, we're talking, you know, blind frog Ranch is 21 miles northeast of the property, and it has exactly the same underground properties occurring. And you go to Mosby mountain, you know, you have ice caves up there, you go to dry for canyon where the petroglyphs are, and there are caves and caverns systems everywhere. And, you know, like I said, the Native American history and maybe other entities or species or races that live there do this as well. You know, the underground system. I mean, it's amazing, when you go under, there's underground lake a sub, it's called a sump in one of them, that's probably about 1400 feet long, which is just about point two, seven miles. And nobody's ever, you know, gone through to see what the depth is there's only been a couple of divers, two divers, as a matter of fact that have traversed it to the next cavern system and then stopped because the next up was even larger, you know, but we I know for a fact that the Native Americans were through that all over the place in the past,

now threw that all over the place in the past when it was underwater or when it was dry.

J james keenan 38:54

So remember that a lot of that is seasonal, based upon the snow melt. So I'm sure there have been times in the last couple 1000 years going back to the Archaic period where it could have been strangely dry and you could have walked, you know, all the way probably from one system to the next. You know, I'm sure connectivity at one point was east west and north and south meeting Eastern west through the UN tall mountains and then north south from the UN Tom islands down under the basin. But, you know, is this connectivity lost permanently or like you said or asked me is it seasonal or you know, it can occur sometimes and other times it can just look at bottle hollow reservoir in on fourth Dushane on the reservation. There was a huge release of gas in 2006 That caused a massive ripple effect on the top that was half a mile in diameter tells you that there was some type of cavity or cavern system And yeah, underneath that. So you know, that part of my hypothesis is still in play. And it's just a matter of finding this transient energy. Now that's just continuously moving. How it's doing it. I just I don't know.

Now from the readings that you've gotten and seen over the years, what, what what is your hypothesis? As far as source? James, what do you like? Does it look to be more of a magnetic source? Does it look to be more of a, like a source of radiation?

J james keenan 40:39

Yeah, it looks like it's, the majority of it is magnetic, you know, magnetic and electromagnetic. And I'm not sure if it's natural, manmade or other made. But what's interesting is you, you know, you have this interaction with specific people, it almost is like, I don't know, it's like, some people have this gift or connectivity to the energy. And this energy, a lot of times acts

like the Havana syndrome, whether those are microwaves or magnetic frequencies that are affecting these people, but it starts somewhere, travels downward across the base, and then affects specific individuals and where that's originating from, I just don't know. Well, you

And that's definitely at the top of the list. The other you know, things that we want to do is we're gonna get backed underground. Go to some of these larger sinkholes and start taking samples. See if you know the gold assays come up pretty high. You know, maybe if it's not a cached, you know, gold bullion Lane underground, maybe there's a ton of ore that's causing a lot of these readings too. Sure. Sure. And yeah, and then we are going to do a lot more of 3d ground imaging at locations that had initial high reads from the metal detection units, the deep net All detectors that we had, I just I didn't have the 3d ground imaging capability at that time.
